

The latest version of the Global Reporting Initiative (GRI) Sustainability Reporting Guidelines is now available for implementation: GRI G4 Guidelines. REPORTING ON WHAT MATTERS MOST: MATERIALITY ASPECTS

G4 represents a new paradigm for sustainability reporting. At the heart of the G4 guidelines is the focus on identifying what is critical for an organisation to manage and change, be that a challenge for today or at some point in the future. Many other changes have been incorporated into the GRI update to G4 and the most important are outlined below.

KEY UPDATES IN THE G4 GUIDELINES

Materiality Focus

Emphasis on what is material – reporting organisation must:

- Determine all relevant material aspects
- Standard Disclosures require reporting on the decision-making processes
- Standard Disclosures require reporting on a list of the material aspects

Application Levels

Application levels A, B and C no longer exist – reporting organisations must:

- Report 'in accordance' with GRI at either Core or Comprehensive level
- General Standard Disclosures apply to both levels
- Comprehensive level requires significantly more General Standard Disclosures

Specific Standard Disclosures

Material aspects require Disclosures on Management Approach (DMA) and Performance Indicators (PI) – reporting organisations must:

- Core level: report on the DMA and at least one PI for each material aspect
- Comprehensive level: report on the DMA and all PIs for each material aspect

Performance Indicators

Performance Indicators have been aligned to other guidelines (e.g. GHG Protocol) – reporting organisations must:

- Report on new Performance Indicators included in G4 (e.g. supply chain issues, anti-corruption, etc.)

Assurance

External assurance is not a requirement but strongly recommended – reporting organisations must:

- Disclose the approach to external assurance

G4: GETTING READY FOR 2015

For organisations large or small, if you plan on reporting in accordance with G4 the clock is already ticking. Organisations have two reporting cycles to switch over to the G4 Guidelines. All organisations need to take a proactive and planned approach when adopting the new guidelines. Our G4 experts can guide you through this process and ensure your organisation meets G4's reporting-transition deadline of 2015.

The G4 Guidelines are made up of 10 Principles, a series of General Standard Disclosures and a series of Specific Standard Disclosures. We provide you with a detailed understanding of all the elements of G4 and support you in identifying and evaluating processes that result in a sustainability report in accordance with G4.
