#### A THRIVING CIVIL SOCIETY

#### **NO ACCOUNTABILITY**

Equally, given the reliance of the sector on donations and resources from the public – as individuals, families and taxpayers, Governments or in pro bono form as volunteers - it is a trade in trust.

Trust is a hard won and easily lost asset. It is harnessed and nourished in transparency and accountability.

# WHAT ARE THE BENEFITS OF THE COMMUNITY PLATFORM?


- Improves fairness and transparency in the evaluation of NGOs
