# CHOOSE SGS SUPPLY CHAIN SOLUTION TO ENSURE COMPLIANCE WITH NEW EU TOY DIRECTIVE 2009/48/EC



### 6 MONTHS LEFT TO BE READY FOR DEADLINE OF 20 JULY 2011

The Toy Safety Directive 2009/48/ EC, which replaces the 20-year old 88/378/EEC Directive, will come into application on the 20th July 2011 (and on the 20<sup>th</sup> July 2013 for the section regulating the use of chemicals in toys as it is a more complicated area). The new Directive brings in particular more references on chemicals by limiting the amounts of certain chemicals that may be contained in materials used for toys.

## WHAT CHANGES FOR MANUFACTURERS, IMPORTERS AND RETAILERS OF TOYS IN THE EU?

Directive 2009/48/EC applies to toys defined as "Any product or material designed or intended whether or not exclusively for use in play by years children under 14 of age". The product does not have to be exclusively intended for playing purposes in order to be considered as a toy.

#### **NEW OBLIGATIONS FOR TOY ACTORS**

Manufacturers shall:

- Draw up the required technical documentation and carry out the applicable conformity assessment procedure.
- Draw up an EC declaration of conformity and affix the CE marking.
- Carry out product safety assessments before placing a toy on the market. Manufacturers are obliged to identify any potential hazards (physical, chemical, electrical, flammability, etc) that a toy may present and rectify them during design process.
- Ensure that their toys bear an identifying mark (batch, serial or model number).
- Ensure production control on manufacturing process. This is the manufacturer's own responsibility to have procedures in place to ensure series production remain in conformity.
- Keep the technical documentation (including the product safety assessment) and the EC declaration of conformity for a period of 10 years after the toy has been placed on the market.

Importers shall ensure that the manufacturer has drawn up the technical documentation and that the toy bears the required conformity marking.

Distributors shall only verify documentation.

#### **NEW MECHANICAL REQUIREMENTS**

- Toys firmly attached to a food product are prohibited
- Toys contained within food must have their own packaging
- New packaging requirements

#### NEW RULES ON WARNINGS AND LABELLING

- Accurate, clearly visible, easily legible and understandable warnings shall be on the toy, on an affixed label or on the packaging and, if appropriate, on the instructions for use which accompany the toy. Warnings shall be visible at the point of sale, including on line shops.
- The misleading use of the warning 'not suitable for children under 3 years' is now legally prohibited.

## DON'T WAIT FOR 20 JULY 2013 TO TAKE INTO ACCOUNT NEW CHEMICAL REQUIREMENTS

- Substances classified as CMR (Carcinogenic, Mutagenic or Toxic for Reproduction) are banned.
- 55 listed allergenic fragrances may not be used in toys, only technically unavoidable traces are allowed up to 100 ppm. Another 11 allergenic fragrances must be declared if present in concentrations higher than 0.01% by weight.
- New migration limits for 19 restricted elements. Heavy metals which are particularly toxic, like lead or mercury, may no longer be intentionally used in toys.
- Nitrosamines/Nitrosable Substances may not be used in toys for children under 36 months and in toys intended to be placed in the mouth.
- Toys shall comply with EU REACH.
